# MESSAGE FROM THE CHAIR

The past academic year was one of extraordinary growth and progress across the Department of Medicine's tripartite mission of patient care, education and research. In fact, by virtually every metric, this last year was one of the most successful in the Department's history - thanks to the commitment of our dedicated faculty, staff, and leadership. With nearly 300 faculty members, the Department of Medicine provides essential leadership to numerous programs across the MUSC campus and South Carolina. As the largest and one of the most active Departments in the MUSC College of Medicine, we are extremely proud of our outstanding physicians, researchers, and staff.

In the pages that follow, I invite you to learn more about the exciting programs, research initiatives, and treatment advances taking place within the Department. Some particularly noteworthy Departmental highlights from this past year include the following:

- Our peers and our patients continue to rank Department of Medicine programs among the best in the nation. In 2019, MUSC Health's Rheumatology program was ranked 13th best in the country by U.S. News & World Report. In addition, our Hematology & Oncology program was highly ranked again this year, coming in at No. 32 and our Nephrology program was recognized as high-performing.
- In research, we had our most impressive year ever in FY19, with the development of multiple new programs, including a number of new K awardees. For the entire Department, we were awarded grants totaling over \$48 million.
- The Department's clinical programs have continued to grow in both volume and quality over the past year. Compared to FY18, the Department's work product (wRVU's) grew by 11% and our new patient visits increased by an extraordinary 19%.
- The Department of Medicine created a Wellness and Burnout Task Force charged with instituting new initiatives and solutions to address wellness and burnout in 2019. As part of this initiative and the Department's commitment to recognizing our faculty and employees for their outstanding work, we expanded recognition opportunities for clinical educator awards and we instituted several new research-oriented awards.
- The Department's core internal medicine residency and subspecialty fellowship
  programs are among the nation's best, and we remain exceptionally proud
  of our outstanding trainees many of whom become leaders at MUSC and
  around the world. Each year, applications to our training programs exceed the
  previous year, and the quality of the applicants has continued to rise along a
  similar trajectory.

Our Department—made up of nine divisions engaged in care at two hospital systems and multiple ambulatory practices—is guided by our vision to provide world-class patient care, to educate the next generation of physicians, and to generate groundbreaking scientific discoveries to improve human health.

I extend my sincere appreciation to the dedicated faculty, fellows, residents, and staff who have contributed to our success so far, and I look forward to celebrating our future accomplishments and new initiatives in the year ahead.

# Telemedicine: Bringing health care closer to home

Providing clinical excellence also involves implementing innovative models of care that offer patients the right care in the right place at the right time. An important way through which MUSC is working to meet its service expansion goals is the use of telehealth services.

Growing from 12 telehealth programs to more than 70, the MUSC Health Center for Telehealth is widely regarded as an industry leader in telemedicine and is one of only two National Telehealth Centers of Excellence designated by the Health Resources and Services Administration (HRSA).

Working with the Center for Telehealth, the Department of Medicine has made a specific commitment to lead new, innovative telehealth initiatives, all aimed to improve the access, quality, and affordability of health care for South Carolinians.

# Diabetes: empowering patients to be involved in their own care

A new diabetes telehealth program offered through the MUSC Center for Health Disparities Research enables patients to monitor diabetes and blood pressure from their homes, with direct transmission of real-time data for viewing by their primary care doctors. This technology provides doctors and nurses with the information they need to make treatment recommendations over the phone between office visits.

"Our goal is to improve diabetic control for low income, rural adults in SC with type II diabetes who otherwise have difficulty accessing primary care," says **Elizabeth Kirkland, M.D., MSCR**, assistant professor and co-medical director of Technology Assisted Case Management for Low Income Adults with Type II Diabetes (TACM2).

Since inception, over 1,000 patients have been enrolled in the year-long program, and approximately 700 participants are still actively being monitored across the state of South Carolina. "What we found is that there are dramatic improvements in A1C levels in the first six months," says Dr. Kirkland.

Kirkland attributes this success to patients being able to manage their own disease. Remote monitoring also reduces the barrier of having to continually go to the doctor's office, saving patients time and money.

# **Endocrinology Telemedicine Clinic**

Beginning in July 2019, the Division of Endocrinology began offering endocrinology services via telemedicine at MUSC's specialty outpatient clinic in Murrells Inlet, SC. During these visits, patients consult with board-certified endocrinologist Harsha Karanchi, M.D., face-to-face via secure video conferencing. A certified medical assistant takes the patient's vital signs in person and the results are instantly provided to Dr. Karanchi, allowing him to provide the same level of care using telemedicine technology as he would during an in-person visit. Patients with diseases ranging from Addison's disease to diabetes to hypothyroidism will greatly benefit from this new service.

### Infectious Diseases Telehealth

In June 2019, the Division of Infectious Diseases launched a new Telehealth Infectious Diseases program led by Amanda Parks, M.D., assistant professor of medicine. To date, the team has conducted over 100 inpatient consults. The program is tailored to the needs of each health system and patient, depending on size, resources and services offered, and includes comprehensive Infectious Diseases (ID) services. "Our primary service is providing expert inpatient consultation for ID cases," says Dr. Parks. "We also offer oversight, management, implementation and training for Infection Control and Antimicrobial Stewardship Programs." In the future, the Division plans to expand its tele-ID services to outpatient clinics as well.

### Palliative Care Telehealth

Palliative care focuses on relieving symptoms and stress in patients with serious illnesses to improve the quality of life for both the patient and their family. MUSC has a robust palliative care team that is pioneering a new project with the Center for Telehealth.

In July 2018, the MUSC palliative care team received a 3-year, \$1.26M grant from the Duke Endowment to create a statewide, palliative care telehealth program. This grant provides money to train and educate partner providers, as well as social workers and chaplains, to deliver true interdisciplinary palliative care, rather than strictly medical care.

"It's a big deal for South Carolina because there is a national shortage of palliative care physicians," says Patrick J. Coyne, MSN, ACHPN, ACNS-BC, FAAN, FPCN, program director of the Palliative Care Program at MUSC. "It's a new, exciting program. It will be one of the pioneers in the country."

### Tele-ICU

MUSC Health offers 24/7 continuous patient monitoring for those in intensive care at partner hospitals. Tele-ICU is a transformational program that uses proactive technology and two-way audiovisual communication to enable MUSC Health's critical care team to provide remote ICU care. Some hospitals use tele-ICU to gain access to intensivists while others use the service for an additional layer of critical care support. System alerts produced by sophisticated algorithm software alert the MUSC critical care team of important trends in a patient's condition, enabling proactive clinical decisionmaking and early identification of potential problems. The Division of Pulmonary, Critical Care, Allergy & Sleep Medicine provides key leadership for the Tele-ICU program where Dee Ford, M.D., professor, is medical director and Nandita Nadiq, M.D., assistant professor, is associate medical director. Currently, there are six South Carolina hospitals enrolled in the Tele-ICU program with plans to expand to 11 this fiscal year.

### Cardiac Telehealth

In May 2019, MUSC launched a new partnership alliance with Hampton Regional Medical Center in Varnville, SC to bring specialty care services to the 32-bed rural hospital via MUSC's telehealth network. As part of this partnership, the Division of Cardiology now offers cardiac telehealth services at Hampton Regional. Cardiologists, Michael Craig, M.D., assistant professor and director of cardiac telehealth, and William Edwards, M.D., telecommunicate with an advanced practice provider at Hampton Regional to manage and provide care for a wide variety of cardiac disorders to both inpatients and outpatients with heart disease.

### Hospitalist Telehealth

In 2019, the Division of General Internal Medicine launched a new Hospitalist Telehealth program at Hampton Regional Medical Center (HRMC). Through this program, MUSC's hospitalists round via telehealth daily with on-site advanced practice providers (APPs) and are on-call as needed for teleconsultation coordinated by the on-site APPs. This service should substantially reduce costs and improve outcomes for HRMC.



# Fostering Innovation

The Department of Medicine has a long tradition of conducting original and outstanding biomedical and clinical research, working to shape the future of medicine by forging new partnerships, developing scientific talent and supporting a culture of curiosity and collaboration.

# **RESEARCH FUNDING**

FY19 was an outstanding year due to the success of the faculty who competed for a record high of \$48M in external research funding and published over 388 articles to further advance that goal.

During the past academic year, the Department of Medicine's research portfolio totaled nearly \$25.4 million in federal awards, \$61.8 million in industry funded grants/clinical trial earnings and over \$9.2 million in non-federal awards. In FY19, Medicine faculty acquired 18 new or competitively renewed federal awards resulting in a 21% increase in total federal grant funding as compared to the previous year. In demonstration of our commitment to advancing the careers of the next generation of researchers, four junior faculty members received a K or career development award.

### DOM RESEARCH SYMPOSIUM

The 13th Annual Department of Medicine Research Symposium was held on April 26, 2019, with an outstanding presentation by Andrew Gewirtz, Ph.D., professor, Institute for Biomedical Sciences, Georgia State University. A total of 65 abstracts were presented at this year's program by junior faculty, postdoctoral fellows, fellows, residents, graduate students, and medical students. Of those abstracts, five were selected for oral presentation awards. In addition, we instituted several new research-oriented awards which were presented at this year's symposium.



Under the leadership of Benjamin Clyburn, M.D., and associate program directors, the Department of Medicine continues to pioneer evidence-based medicine training. With 99 internal medicine resident trainees, and 88 fellows across nine programs, competitive training opportunities span the Department, College of Medicine, and beyond. MUSC's Internal Medicine Residency program prioritizes collaboration, autonomy, and scholarship, and facilitates learning about highly diverse patients and diseases in a number of practice settings.

The Department offers fellowship programs across all nine divisions to provide extraordinary subspecialty training with focus for clinical, clinician-educator, and research careers. The program recruits trainees from the top medical schools and residency programs in the country, and its alumni are among the most distinguished medical professionals in the U.S. and abroad, including many of the current faculty of MUSC.

### HIGHLIGHTS AND ACCOMPLISHMENTS

2018-19 graduates achieved a 100% percent pass rate on the American Board of Internal Medicine (ABIM) Certification Examination.

In March 2019, the Department of Medicine opened its newly renovated internal medicine residency education space. The new space is an open, contemporary, functional work area that is extremely welcoming and efficient. "The core difference is that we now have much more dedicated space for the full care team — including attending physicians, upper level residents, pharmacists, interns, and medical students — to collaborate and coordinate care, which in turn enhances patient care and outcomes," said Devin Blankinship, M.D., one of the chief residents. The renovation also significantly expands and fully integrates technology usage throughout the teaching and research program. The space accommodates residents across multiple programs and enables the Department to enhance both collaboration and innovation, two of the core values at the Medical University of South Carolina.

The Susan Pearlstine Sarcoidosis Center of Excellence: Improving the lives of patients with sarcoidosis

The Department of Medicine is deeply grateful for Susan Pearlstine's generous financial support in establishing the Susan Pearlstine Sarcoidosis Center of Excellence. MUSC now has a robust, nationally recognized sarcoidosis program as a direct result of Susan Pearlstine's vision and her \$5 million gift to MUSC in 2013. The Center has enabled MUSC to significantly enhance treatment and care for patients with sarcoidosis while also engaging in clinical trials that could lead to new treatment options.

Under the direction of Ennis James, M.D., the Center has received numerous national honors and awards. In 2019, the Center became the first clinic in the state to be recognized as a Foundation for Sarcoidosis Research (FSR) and World Association of Sarcoidosis and Other Granulomatous Disorders (WASOG) Sarcoidosis Center of Excellence. This designation provides formal recognition of MUSC's commitment to meeting the needs of sarcoidosis patients and efforts to keep abreast of the ongoing advances in sarcoidosis treatment and research.

Physicians specializing in sarcoidosis are available to see patients five days a week. MUSC uses a multidisciplinary team approach to make sure patients quickly see the best doctors for their case. Sarcoidosis care team members actively collaborate with other specialists, including those in dermatology, rheumatology, ophthalmology, cardiology, otolaryngology, and neurology. Over the past few years, the Center has increased its total patient encounters by over 40%, drawing patients from South Carolina, Florida, Georgia, Kentucky, North Carolina, and Tennessee.



In promising recent developments:

- In 2019, the Center hired a new program manager, Maria Hoffman, MHA, to coordinate and streamline care for patients with sarcoidosis.
- The Center holds quarterly patient support group meetings that serve as an educational and social forum for patients, caregivers, and family members of those affected by sarcoidosis.
- In 2018, the Center was selected as one of 12 international sites to join the Foundation for Sarcoidosis Research Clinical Studies Network.

Because of Susan Pearlstine's vision and financial support, the future is very bright for the Sarcoidosis Center at MUSC and the ever-increasing number of sarcoidosis patients who receive care at MUSC.
