2019 - A Banner Year for Pediatric ENT across the Lowcountry

In April, we opened the MUSC Children's Health R. Keith Summey Medical Pavilion in North Charleston, a 57 million-dollar, 100,000 square foot, state of the art outpatient facility that offers 27 pediatric specialties, radiology services, outpatient surgery, and after-hours care under one roof. The Summey Medical Pavilion has been a great success, exceeding expected numbers of outpatient visits to date. The facility includes a purpose-built pediatric otolaryngology outpatient unit with integrated pediatric audiology space.

Later in 2019, MUSC Children's Hospital will relocate to the new eleven story, 600,000 square foot MUSC Shawn Jenkins Children's Hospital on the corner of Calhoun Street and Courtenay Drive. The building will feature a twenty percent increase in inpatient beds, eight pediatric operating rooms, a substantial increase in space for patients and families, an expanded Labor and Delivery unit, and expansion of the Advanced Fetal Care Center. The facility will allow MUSC to continue to be the state's leader in children's healthcare.
